Identity Theft - Protect Yourself!

You can protect yourself against fraud and Identity Theft by never providing your personal or account information in response to any unsolicited e-mails or phone calls. We will occasionally ask for your social security number and other personal information if you apply for an account or loan with us. We use your SSN only for legitimate business purposes such as to pull your credit report and to verify your identity.
