Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do. The types of personal information we collect and share depend on the product or service you have with us. This information can include: Social Security number Income Account Balances Payment History Credit history When you are no longer our customer, we continue to share your information as described in this notice. How? All financial companies need to share customer's personal information to run their everyday business. In the section below, we list the reasons financial companies share their customer's information; the reasons the Bank of Manhattan chooses to share; and whether you can limit this sharing.
