These measures include computer safeguards and secured file and buildings. We safeguard your information by using cookies.				
How does MHPFCU collect my personal information?	We collect your personal information, for example, when you Open an account or deposit money Pay your bills or apply for a loan Use your credit or debit card We also collect your personal information from others, such as credit bureaus, affiliates or other companies.				
Why can't I limit all sharing?	Federal law gives you the right to limit only Sharing for affiliates' everyday business purposes information information about your creditworthiness

	Definitions
Affiliates	Companies related by common ownership or control. They can be financial and nonfinancial companies. • MHPFCU has no affiliates
Nonaffiliates	Companies not related by common ownership or control. They can be financial and nonfinancial companies. • MHPFCU does not share with non-affiliates so that they can market to you.
Joint marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you. Our joint marketing partners include insurance companies.
