We also maintain other physical, electronic and procedural safeguards to protect this information and we limit access to information to those employees for whom access is appropriate.

Definitions	
Affiliates	Companies related by common ownership or control. They can be financial and non-financial companies. • Mills County State Bank does not share with our affiliates.
Nonaffiliates	Companies not related by common ownership or control. They can be financial and non-financial companies. • Mills County State Bank does not share with nonaffiliates so they can market to you.
Joint Marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you. • Mills County State Bank doesn't jointly market.

Consumer Complaint Process

MILLS COUNTY STATE BANK is chartered under the laws of the State of Texas and by state law is subject to regulatory oversight by the Texas Department of Banking. Any consumer wishing to file a complaint against Mills County State Bank should contact the Texas Department of Banking. Mills County State Bank also engages in currency exchange business as an authorized delegate

of *American Express Company* licensed under Chapter 151 of the Texas Finance Code. If you have any complaints regarding America Express currency exchange activity, you should first contact:
