What?

- Social Security number and income

- Credit history and credit scores

Non-affiliates	Companies not related by common ownership or control. They can be financial and nonfinancial companies. • MRV Banks does not share with non-affilifates so they can market to you.	
Joint Marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you. • MRV Banks does not jointly market.
