<b>FACTS</b>	What does Mutual Credit Union do with your personal information?
What?	<p>The types of personal information we collect and share depend on the products or service you have with us. This information can include:</p> <ul style="list-style-type: none"> <li>• Social Security number and credit history</li> <li>• account balances and payment history</li> <li>• transaction or loss history and wire transfer instructions</li> </ul> <p>When you are <i>no longer</i> our member, we continue to share your informatoin as described in this notice.</p>
Why?	Financial companies choose how they share Your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share and protect your personal information. Please read this notice carefully to understand what we do.
How?	All financial companies need to share customers' personal information to run their everyday business. In the section below, we list reasons financial companies can share their customers' personal informatoin, the reasons Mutual Credit Union chooses to share; and whether you can limit this sharing.

Reasons we can share your personal information	Does the Credit Union share?	Can you limit this sharing?
<b>For our everyday business purposes</b> - such as to process your transactions, maintain your account(s), respond to court orders and legal investigations or report to credit bureaus	<b>Yes</b>	<b>No</b>
<b>For our marketing purposes</b> - to offer our products and services to you	<b>No</b>	<b>We don't share</b>
<b>For our joint marketing with other financial companies</b>	<b>No</b>	<b>We don't share</b>
<b>For our affiliates' everyday business purposes</b> - informatoin about your transactions and experiences	<b>Yes</b>	<b>We don't share</b>
<b>For our affiliates' everyday business purposes</b> - informatoin about your creditworthiness	<b>Yes</b>	<b>We don't share</b>
<b>For our affiliates to market to you</b>	<b>No</b>	<b>We don't share</b>
<b>For non-affiliates to market to you</b>	<b>No</b>	<b>We don't share</b>

<b>What We Do</b>	
How does Mutual Credit Union protect my personal information?	To protect your personal informatoin from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.
How does Mutual Credit Union collect my personal information?	<p>We collect your personal informatoin, for example, when you</p> <ul style="list-style-type: none"> <li>• open an account or apply for a loan</li> <li>• apply for financing or make a wire transfer</li> <li>• show your driver's license</li> </ul> <p>We also collect your personal information from others, such as credit bureaus or other companies.</p>
Why can't I limit all sharing?	<p>Federal law gives you the right to limit only</p> <ul style="list-style-type: none"> <li>• sharing for affiliates' everyday business purposes - informatoin about your creditworthiness</li> </ul>

- your creditworthiness
- affiliates from using your information to market you
- sharing for non-affiliates to market you

State laws and individual companies may give you additional rights to limit sharing.

#### Definitions

Affiliates	<p>Companies related by common ownership or control. They can be financial and non-financial companies</p> <ul style="list-style-type: none"> <li>• <i>Mutual Credit Union has no affiliates</i></li> </ul>
Non-affiliates	<p>Companies not related by common ownership or control. They can be financial and non-financial companies</p> <ul style="list-style-type: none"> <li>• <i>Mutual Credit Union does not share with non-affiliates so they can market to you</i></li> </ul>
Joint Marketing	<p>A formal agreement between non-affiliated financial companies that together market financial products or services to you</p> <ul style="list-style-type: none"> <li>• <i>Mutual Credit Union doesn't jointly market</i></li> </ul>
