WHAT DOES NEIGHBORHOOD NATIONAL BANK DO WITH YOUR PERSONAL INFORMATION?

Why?

 $\label{prop:cond} \mbox{Financial companies choose how they share your personal information. Federal law}$ gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.

What?

The types of personal information we collect and share depend on the product or service you have with us. This information can include:

- Social Security number and Checking Account Information
- Credit History and Employment Information
- Assets and Overdraft History

When you are no longer our customer, we continue to share your information as described in this notice.

How?

All financial companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customer's personal information; the reasons Neighborhood National Bank chooses to share; and whether you can limit this sharing.

How does Neighborhood National Bank protect my personal information?

To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.

We limit the access to your personal information only to those employees with a need to know such

How does Neighborhood National Bank collect my personal information?

We collect your personal information, for example,

- Open an account or make deposits or withdraw funds from your account
- Pay your bills or apply for a loan
- Use your credit or debit card.

We also collect your personal information from others, such as credit bureaus, affiliates or other companies.

Why can't I limit all sharing?

Federal law gives you the right to limit only

• sharing for nonaffiliates to market to you. State laws and individual companies may give you additional rights to limit sharing.

# Definitions

Affiliates

Companies related by common ownership or control. They can be financial and nonfinancial companies.

■ Neighborhood National Bank does not share with our affiliates, Neighborhood Capital Advisors or Neighborhood Opportunities Corporation.

Nonaffiliates

Companies not related by common ownership or control. They can be financial and nonfinancial companies.

 Neighborhood National Bank does not share with nonaffiliates so they can market to you.

Joint marketing

A formal agreement between nonaffiliated financial companies that together market financial products or services to you.

 Neighborhood National Bank does not jointly market.
