

**FACTS****WHAT DOES NORTH DALLAS BANK & TRUST CO.  
DO WITH MY PERSONAL INFORMATION?**

<b>Why?</b>	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.
<b>What?</b>	<p>The types of personal information we collect and share depend on the product or service you have with us. This information can include:</p> <ul style="list-style-type: none"> <li>• Social Security number</li> <li>• Account balances</li> <li>• Payment history</li> <li>• Transaction history</li> <li>• Account transactions</li> <li>• Checking account information</li> </ul>
<b>How?</b>	All financial companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal information; the reasons North Dallas Bank & Trust Co. chooses to share; and whether you can limit this sharing.

## What We Do

### How does North Dallas Bank & Trust Co. protect my personal information?

To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings. We maintain other physical, electronic and procedural safeguards to protect this information and we limit access to those employees for whom it is appropriate.

### How does North Dallas Bank & Trust Co. collect my personal information?

We collect your personal information, for example, when you

- Open an account
- Provide account information
- Apply for a loan
- Make deposits or withdrawals from your account
- Give us your contact information

We also collect your personal information from others, such as credit bureaus, affiliates or other companies.

### Why can't I limit all sharing?

Federal law gives you the right to limit only

- sharing for affiliates' everyday business purposes- information about your creditworthiness
- affiliates from using your information to market to you
- sharing for nonaffiliates to market to you

State laws and individual companies may give you additional rights to limit sharing. See below for more on your rights under state law.

## Definitions

### Affiliates

Companies related by common ownership or control. They can be financial and nonfinancial companies.

- *North Dallas Bank & Trust Co. does not share with our affiliates.*

### Nonaffiliates

Companies not related by common ownership or control. They can be financial and nonfinancial companies.

- *North Dallas Bank & Trust Co. does not share with nonaffiliates.*

### Joint marketing

A formal agreement between nonaffiliated financial companies that together market financial products or services to you.

- *North Dallas Bank & Trust Co. does not jointly market.*
