FACTS	WHAT DOES NORTHEAST COMMUNITY BANK (NECB) AND HAYDEN WEALTH MANAGEMENT (HWM), A DIVISION OF NORTHEAST COMMUNITY BANK, DO WITH YOUR PERSONAL INFORMATION?
Why?	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.
What?	<p>The types of personal information we collect and share depend on the product or service you have with us. This information can include:</p> <ol style="list-style-type: none"> 1. Social Security number and transaction history 2. checking account information and payment history 3. account balances and account transactions <p>When you are <i>no longer</i> our customer, we continue to share your information as described in this notice.</p>
How?	All financial companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal information; the reasons NorthEast Community Bank chooses to share; and whether you can limit this sharing.

Why can't I limit all sharing?	<p>Federal law gives you the right to limit only</p> <ol style="list-style-type: none"> 1. sharing for affiliates' everyday business purposes—information about your creditworthiness 2. affiliates from using your information to market to you 3. sharing for nonaffiliates to market to you <p>State laws and individual companies may give you additional rights to limit sharing.</p>
Definitions	
Affiliates	<p>Companies related by common ownership or control. They can be financial and nonfinancial companies.</p> <ol style="list-style-type: none"> 1. NECB and HWM have no affiliates
Nonaffiliates	<p>Companies not related by common ownership or control. They can be financial and nonfinancial companies.</p> <ol style="list-style-type: none"> 1. NECB and HWM do not share your personal information with non-affiliates for marketing purposes
Joint marketing	<p>A formal agreement between nonaffiliated financial companies that together market financial products or services to you.</p> <ol style="list-style-type: none"> 1. NECB and HWM do not have any joint marketing agreements
