### Fraud Prevention- Lottery Scams

Con artists target millions of people every year. When they succeed, they can seriously affect the lives of victims and their families.

"You've Just Won a Foreign Lottery" If this sounds too good to be true, you're right. Odds are it's a scam. It happens like this... someone calls, emails, or notifies you by mail that you have won a lottery and all you need to do is mail or wire a small amount for taxes and fees to claim your prize. Just hang up the phone or ignore the email. Never wire or send money to anyone, anywhere, who says you've won a prize. No legitimate lottery should ask you for money to claim your prize.

Older Americans are often targeted by scammers. Speak with your older loved ones about the consequences of foreign lottery scams. A few protective measures and a simple conversation about avoiding scams could preserve their financial well-being.

Why?	Financial companies choose how they share your personal information. Federal law

What?	The types of personal information we collect and share depend on the product or service you have with us. This information may include: - Social Security number and income

### Change in Share Draft NSF Policy

Effective May 1, 2013, we are changing our Share Draft NSF Policy. If you have an NSF Draft or NSF ACH on your share draft account, we will call you to notify you about the NSF at the phone number you have listed on your account.

For Share Draft NSF items, we will refund \$10 of your NSF fee per item if you are able to deposit funds to pay the item by 12pm that same day.

For ACH NSF items, we will refund \$10 of your NSF fee per item if you are able to deposit funds to pay the item by 12pm the following day.
