How does Orange Bank of Florida protect my personal information?	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.	
How does Orange Bank of Florida collect my personal information?	 We collect your personal information, for example, when you Open an account Apply for a loan Make deposits or withdrawals from your account We also collect your personal information from others, such as credit bureaus, affiliates, or other companies. 	
Why can't I limit all sharing?	 Federal law gives you the right to limit only sharing for affiliates' everyday business purposes - information about your creditworthiness affiliates from using your information to market to you sharing for nonaffiliates to market to you State laws and individual companies may give you additional rights to limit sharing. 	
What happens when I limit sharing for an account I hold jointly with someone else?	Your choices will apply to everyone on your account.	
Definitions		
Affiliates	 Companies related by common ownership or control. They can be financial and non-financial companies. Our affiliates include: Companies with a Floridian Financial Group and Floridian Bank name 	
Nonaffiliates	Companies not related by common ownership or control. They can be financial and non-financial companies. • Nonaffiliates we share with can include direct marketing company.	
Joint Marketing	 A formal agreement between nonaffiliated financial companies that together market financial products or services to you. Orange Bank of Florida doesn't jointly market.
