## WHAT DOES OWOSSO COLUMBUS CREDIT UNION DO WITH YOUR PERSONAL INFORMATION?

### Why?

Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.

#### What?

The types of personal information we collect and share depend on the product or service you have with us. This information can include:

- Social Security number and IncomeName and Address
- Transaction History and Account Balances

#### How?

All financial companies need to share **members'** personal information to run their everyday business. In the section below, we list the reasons financial companies can share their **members'** personal information; the reasons **Owosso Columbus Credit Union** chooses to share; and whether you can limit this sharing.

Affiliates	Companies related by common ownership or control. They can be financial and nonfinancial companies.	
	■ We have no affiliates	
Nonaffiliates	Companies not related by common ownership or control. They can be financial and nonfinancial companies.	
	We share information with non affiliates such as; Insurance Companies, ATM plastic card processors, Data Processors, Share Draft Printers, Mortgage Companies.	
Joint marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you.
