Nonaffiliates	Companies not related by common ownership or control. They can be financial and nonfinancial companies. Parkway Bank & Trust Co. does not share with nonaffiliates so they can market to you.
Joint marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you. Parkway Bank & Trust Co. doesn't jointly market.
