FACTS	WHAT DOES PARTNERS BANK OF CALIFORNIA DO WITH YOUR PERSONAL INFORMATION?
Why?	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.
What?	 The types of personal information we collect and share depend on the product or service you have with us. This information can include: Social Security number and income account balances and payment history account transactions and overdraft history When you are <i>no longer</i> our customer, we continue to share your information as described in this notice.
How?	All financial companies need to share customer' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal information; the reason Partners Bank of California chooses to share; and whether you can limit the sharing.

Unless you register with us for a service (such as our Online Banking service), the cookie does not provide us with any personally identifying information about you, such as your name or address.

We have procedures in place that help us to maintain your financial information in an accurate and up-to-date manner. If you believe that your account information is inaccurate or incomplete, however, please contact us promptly so that we can investigate the error.

We feel strongly about protecting the privacy of children and teenagers. As such, we do not knowingly collect personally identifiable information from persons under the age of 18 through our web site.
