Why?

Financial companies choose how they share your personal information. - Social Security number and income

How?

All financial companies need to share members' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their members' personal information; the reasons PAFCU chooses to share; and whether you can limit this sharing.

Companies related by common ownership or control. They can be financial and nonfinancial companies.

Nonaffiliates

Companies not related by common ownership or control. They can be financial and nonfinancial companies.

Joint Marketing

A formal agreement between non-affiliated financial companies that together market financial products or services to you. · Our joint marketing partners include: insurance companies and financial planners, car
