Facts Information

Why?

Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.

What?

The types of personal information we collect and share depend on the product or service you have with us. This information can include:

- Social Security number
- Credit history
- Account balances
- Credit card or other debt
- Payment history
- Wire transfer instructions

When you are no longer our customer, we continue to share your information as described in this notice.

How?

| How does Peoples Bank of Greensboro collect my personal information? | <p>We collect your personal information, for example, when you:</p> <ul style="list-style-type: none"> • Open an account • Apply for a loan • Make deposits or withdrawals from your account • Provide account information • Make a wire transfer <p>We also collect your personal information from others, such as credit bureaus, affiliates or other companies.</p> |
| How does Peoples Bank of Greensboro collect my personal information? | <p>Federal law gives you the right to limit only:</p> <ul style="list-style-type: none"> • sharing for affiliates' everyday business purposes - information about your creditworthiness • affiliates from using your information to market to you • sharing for non-affiliates to market to you <p>State laws and individual companies may give you additional rights to limit sharing.</p> |
