What does Pilot Bank do with your personal information?

Why?

Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.

What?

The types of personal information we collect and share depend on the product or service you have with us. This information can include:

- Social Security number and income
- Account balances and transaction history
- Credit history and payment history

When you are no longer our customer, we continue to share your information as described in this notice.

How?

All financial companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal information; the reasons Pilot Bank chooses to share; and whether you can limit this sharing. How does Pilot Bank protect my personal information?

Resources we can share on your personal information
For our everyday business purposes — such as to process your transactions, maintain your account(s), respond to court orders
For our marketing purposes -- to offer our products and services to you
For joint marketing with other financial companies
For our affiliates' everyday business purposes -- information about your transactions and experiences
For our affiliates' everyday business purposes -- information about your creditworthiness
For nonaffiliates to market to you

What we do

How does Pilot Bank collect my personal information?

To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.

How does Pilot Bank collect my personal information?

We collect your personal information, for example, when you

- Open new accounts or make deposits or withdrawals from your account
- Pay your bills or apply for a loan
- Use your debit card

We also collect your personal information from others, such as credit bureaus or other companies.

Why can't I limit all sharing

Federal law gives you the right to limit only

- Sharing for affiliates' everyday business purposes—information about your creditworthiness
- Affiliates from using your information to market to you
- Sharing for non-affiliates to market to you

State laws and individual companies may give you additional rights to limit sharing.

Definitions

Affiliates

Companies related by common ownership. They can be financial and nonfinancial companies.

- *Our affiliate is National Aircraft Finance Company, Inc., (NAFCO).*

Non-affiliates

Companies not related by common ownership or control. They can be financial and nonfinancial companies.

- *Pilot Bank does not share with non-affiliates so they can market to you.*

Joint marketing

A formal agreement between non-affiliated financial companies that together market financial products or services to you.

- *Pilot Bank doesn't jointly market.*
