

FACTS	WHAT DOES PRINCIPAL BANK DO WITH YOUR PERSONAL INFORMATION?
Why?	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.
What?	 The types of personal information we collect and share depend on the product or service you have with us. This information can include: Social Security number and income Account balances and payment history Credit history and credit scores
How?	All financial companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal information; the reasons Principal Bank chooses to share; and whether you can limit this sharing.

When you are <i>no longer</i> our customer, we continue to share your information as described in this notice. However, you can contact us at any time to limit our sharing.

Definitions	
Affiliates	Companies related by common ownership or control. They can be financial and nonfinancial companies.
	Our affiliates include companies with a Principal Financial Group name, financial companies such as Principal Life Insurance Company, Principal National Life, Princor Financial Services Corporation, Principal Trust Company, Principal Global Investors LLC, Principal Real Estate Investors LLC, nonfinancial companies, such a Principal Wellness Company and others, such as Principal Funds, Inc.
Nonaffiliates	Companies not related by common ownership or control. They can be financial and nonfinancial companies.
	Principal Bank does not share with nonaffiliates so they can market to you.
Joint marketing	Principal Bank does not share with nonaffiliates so they can market to you. A formal agreement between nonaffiliated financial companies that together market financial products or services to you.

- Vermont Residents: We automatically treat customers with a Vermont mailing address as having limited sharing with our affiliates as provided on page one.
- California Residents: State law requires financial institutions to obtain your consent prior to sharing information about you with our affiliates. To opt out of affiliate sharing, call us toll free at 1-800-672-3343 or complete and return the Important Privacy Choice for California Consumers form to us.
- We may change our privacy practices at times. We will give you a revised notice when required by law.
