What?	 The types of personal information we collect and share depend on the product or service you have with us. This information can include: Social Security number and income account balance and payment history credit history and credit score When you are <i>no longer</i> our member, we continue to share your information as described in this notice. 				
How?	All financial companies need to share member's personal information to run their everyday business. In the section below, we list the reasons financial companies share their member's personal information; the reasons Prospectors Federal Credit Union chooses to share; and whether you can limit this sharing.

How does Prospectors Federal Credit Union protect my personal information?	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.
How does Prospectors Federal Credit Union collect my personal information?	 We collect your personal information, for example when you Open an account or apply for a loan Deposit money or use your credit or debit card Pay your bills We also collect information from others such as credit bureaus or other companies.
Why can't I limit all sharing? Definitions	
Affiliates	 Companies related by common ownership or control. They can be financial and non-financial companies. Prospectors Federal Credit Union does NOT share with our affiliates
Non-affiliates	 Companies not related by common ownership or control. They can be financial and non-financial companies. Prospectors Federal Credit Union does NOT share with non-affiliates so they can market to you
Joint marketing	 A formal agreement between non-affliated financial companies that together market financial products or services to you. Prospectors Federal Credit Union does NOT jointly market

Other important information

California law limits an institution from sharing with non-affillated third parties except as necessary for our everday business purposes, or to offer our products and services to you, unless you have given us permission.

California law limits an institution from sharing information with affillates, except as necessary for our everday business purpose, or to offer our products and services to you, unless we have provided you an opportunity to opt-out of this sharing.

Prospectors Federal Credit Union does not share information with affillates or non-affillates for other than our everday buisness purposes or to offer our products and services to you.
