WHY?	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.	
WHAT?	The types of personal information we collect and share depend on the product or service you have with us. This information can include: - Social Security Number - Date of Birth - Address - Legal Name - Account Number - E-mail address When you are no longer our customer, we continue to share your information as described in this notice.	
HOW?	All financial companies need to share member's personal information to run their everyday business. In the section below, we list the reasons financial companies can share their member's personal information; the reasons Railway Credit Union chooses to share; and whether you can limit this sharing.
