What Does Regal Financial Bank Do With Your Personal Information?

Why?

Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.

What?

The types of personal information we collect and share depend on the product or service you have with us. This information can include: (1) Social Security number and income (2) assets and employment information (3) credit history and credit scores. When you are no longer our customer, we may continue to share your information as described in this notice.

How?

All financial companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal information; the reasons Regal Financial Bank chooses to share; and whether you can limit this sharing.

What We Do How does Regal Financial Bank protect my personal information? How does Regal Financial Bank protect my personal information? How does Regal Financial Bank collect my personal information? We collect your personal information, for example, when you: (1) open an account or deposit money (2) apply for a loan or make a wire transfer (3) use your credit or debit card or Bill Pay. We also collect your personal information from other companies, such as credit bureaus and affiliates.

| Why can't I limit all sharing? | Federal law gives you the right to limit only: (1) sharing for affiliates' everyday business purposes – information about your creditworthiness (2) affiliates from using your information to market to you (3) sharing for nonaffiliates to market to you. State laws and individual companies may give you additional rights to limit sharing. |
