#### What We Do

How does Richton Bank & Trust Co. protect my personal information?	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.  We also maintain other physical, electronic and procedural safeguards to protect this information and we limit access to information to those employees for whom access is appropriate.
How does Richton Bank & Trust Co. collect my personal information? Why can't I limit all sharing? #### **Definitions**

Affiliates	Companies related by common ownership or control. They can be financial and non-financial companies.  • Richton Bank & Trust Co. has no affiliates.
Nonaffiliates	Companies not related by common ownership or control. They can be financial and non-financial companies.  • Richton Bank & Trust Co. does not share with nonaffiliates so they can market to you.
Joint Marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you.  • Richton Bank & Trust Co. doesn't jointly market.
