# WHAT DOES ROBINS FEDERAL CREDIT UNION DO WITH YOUR PERSONAL INFORMATION?

### Whv?

Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.

### What?

The types of personal information we collect and share depend on the product or service you have with us. This information can include:

- Social Security number and Name
- Address and Telephone Number
- Email Address and Income

When you are *no longer* our customer, we continue to share your information as described in this notice.

### How?

All financial companies need to share customers' non-public personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' non-public personal information; the reasons Robins Federal Credit Union chooses to share; and whether you can limit this sharing.

What we do		
How does Robins Federal Credit Union protect my personal information?	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.	
How does Robins Federal Credit Union collect my personal information?	<ul> <li>We collect your personal information, for example, when you</li> <li>open an account or apply for a loan</li> <li>send emails or other types of communication to the credit union</li> <li>conduct transactions with us or others</li> <li>We also collect information we receive from consumer reporting agencies and other third parties such as market research firms.</li> </ul>	
Why can't I limit all sharing?	<ul> <li>Federal law gives you the right to limit only</li> <li>sharing for affiliates' everyday business purposes—information about your creditworthiness</li> <li>affiliates from using your information to market to you</li> <li>sharing for nonaffiliates to market to you</li> <li>State laws and individual companies may give you additional rights to limit sharing.</li> </ul>	
What happens when I limit sharing for an account I hold jointly with someone else?	Robins Federal Credit Union will treat an opt-out request from any one party to an account as if all of you chose to opt-out.	
Definitions		
Affiliates	Companies related by common ownership or control. They can be financial and nonfinancial companies. <ul> <li>Robins Investment &amp; Retirement Services</li> </ul>	
Nonaffiliates	Companies not related by common ownership or control. They can be financial and nonfinancial companies.  Robins Federal Credit Union does not share with nonaffiliates	
Joint marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you. <ul> <li>Robins Federal Credit Union doesn't jointly market</li> </ul>
