FACTS	WHAT DOES SEAWAY BANK AND TRUST COMPANY DO WITH YOUR PERSONAL INFORMATION?
Why?	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.
What?	<p>The types of personal information we collect and share depends on the product or service you have with us. This information can include:</p> <ul style="list-style-type: none">• Social Security number• Income• Account balances• Payment History• Credit history• Checking account information <p>When you are <i>no longer</i> our customer, we continue to share your information as described in this notice.</p>
How?	All financial companies need to share non public personal information to run their everyday business. In the section below, we list the reasons financial companies can share their non public personal information; the reasons Seaway Bank and Trust Company chooses to share; and whether you can limit this sharing.

Reasons we can share your personal information	Does Seaway Bank and Trust Company share?	Can you limit this sharing?
For our everyday business purposes – such as to process your transactions, maintain your accounts(s), respond to court orders and legal investigations, or report to credit bureaus	Yes	No

For our affiliates' everyday business purposes – information about your transactions and experiences	No	We don't share

What We Do

How does Seaway Bank and Trust Company protect my personal information?

To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.

How does Seaway Bank and Trust Company collect my personal information?

We collect your personal information, for example, when you

- Open an account
- Deposit money
- Apply for a loan
- Use your debit or credit card
- Give us your contact information

We also collect your personal information from others, such as credit bureaus or other companies.

Why can't I limit all sharing?

Federal law gives you the right to limit only

- sharing for affiliates' everyday business purposes – information about your creditworthiness
- affiliates from using your information to market to you
- sharing for nonaffiliates to market to you

State laws and individual companies may give you additional rights to limit sharing. See below for more on your rights under state law.

Definitions

Affiliates

Companies related by common ownership or control. They can be financial and non-financial companies.

- ***Seaway Bank and Trust Company does not share with our affiliates.***

Nonaffiliates

Companies not related by common ownership or control. They can be financial and non-financial companies.

- ***Seaway Bank and Trust Company does not share with nonaffiliates to market to you.***

Joint Marketing

A formal agreement between nonaffiliated financial companies that together market financial products or services to you.

- ***Our joint marketing partners include credit card companies.***

Other Important Information

For Illinois Customers. We will not share personal information with nonaffiliates either for them to market to you or for joint marketing – without your authorization.
