FACTS: What does Secured Advantage Federal Credit Union do with your personal information?

Why?

Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to

What?	The types of personal information we collect and share depend on the product or service you have with us. This information can include: *Your Social Security number and your mailing address
How?	All financial companies need to share member's personal information to run their everyday business. In the section below, we list the reasons financial companies can share their member's personal information; the reasons Secured Advantage FCU chooses to share; and whether you can limit this sharing.

Definitions

<p>Affiliates</p>	<p>Companies related by common ownership or control. They can be financial and nonfinancial companies.</p>
<p>Non-Affiliates</p>	<p>Companies not related by common ownership or control. They can be financial or nonfinancial companies.</p>
<p>Joint Marketing</p>	<p>A formal agreement between non-affiliated financial companies that together market financial products or services to you.</p>
