How?	All financial companies need to share customers' personal information to run their everyday business. In the sec- tion below, we list the reasons financial companies can share their customers' personal information; the reasons

Why can't I limit all sharing?	<ul> <li>Federal law gives you the right to limit only</li> <li>sharing for affiliates' everyday business purposes-information about your creditworthiness</li> <li>affiliates from using your information to market to you</li> <li>sharing for nonaffiliates to market to you</li> <li>State laws and individual companies may give you additional rights to limit sharing.</li> </ul>

Affiliates	<ul> <li>Companies related by common ownership or control. They can be financial and nonfinancial companies.</li> <li>Our affiliates include financial companies owned by Security National Corporation</li> </ul>			
Nonaffiliates	<ul> <li>Companies not related by common ownership or control. They can be financial and nonfinancial companies.</li> <li>Security National Corporation and its Affiliated Banks do not share with nonaffiliates so they can market to you.</li> </ul>			
Joint marketing	<ul> <li>A formal agreement between nonaffiliated financial companies that together market financial products or services to you.</li> <li>Security National Corporation and its Affiliated Banks do not jointly market.</li> </ul>
