WHAT DOES HAMPTON ROADS BANKSHARES, INC. DO WITH YOUR PERSONAL INFORMATION?

WHY?

Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.

WHAT?

The types of personal information we collect and share depend on the product or service you have with us. This information can include:

- Social security number and income
- Account balances and payment history
- Credit history and credit scores

HOW?

All financial companies need to share customers' personal information to run their everyday business. What happens when I limit sharing for an account I hold jointly with someone else?	Your choices will apply to everyone on your account.

Affiliates	Our affiliates include companies with a common corporate identity of Hampton Roads Bankshares, Inc.; financial companies such as Bank of Hampton Roads, Gateway Bank & Trust, a division of Bank of Hampton Roads, and Shore Bank; nonfinancial companies, such as Gateway Investment Services, Inc.; Gateway Bank Mortgage, Inc.; DNJ Gateway Mortgage, LLC; and Hampton Roads Investments.	
Nonaffiliates	Companies not related by common ownership or control. They can be financial and nonfinancial companies.	
Joint Marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you.
