Definitions			
Affiliates	Companies related by common ownership or control. They can be financial and non-financial companies. Show Me Credit Union has no affiliates.		
Non-affiliates	Companies not related by common ownership or control. They can be financial and non-financial companies. Non-affiliates we share with can include companies such as mortgage companies, insurance companies and direct marketing companies.		
Joint marketing	A formal agreement between non-affiliated financial companies that together market financial products or services to you. Joint marketing can include companies such as the Illinois Credit Union League for our VISA credit card program.
