We will not share personal information from deposit orshare relationships with nonaffiliates either for them to market to you or for joint marketing - without your authorization. For vermont members, we will not share personal information with nonaliliates either for them to market to you only joint

marketing - without your authorization, and we will not share personal information with affiliates about yourcreditworthiness

without your authorization.
