Nonaffiliates	<ul> <li>Companies not related by common ownership or control. They can be financial and nonfinancial companies.</li> <li><i>Nonaffiliates we share with can include companies such as mortgage companies and insurance companies</i></li> </ul>
Joint marketing	<ul> <li>A formal agreement between nonaffiliated financial companies that together market financial products or services to you.</li> <li>Southern Heritage Bank's joint marketing partners include our credit card processor.</li> </ul>
