Why?	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.
What?	The types of personal information we collect and share depend on the product or service you have with us. This information can include: • Social Security number and account balances • programs bistory and credit history
How?	 payment history and credit history account transactions and transaction history When you are <i>no longer</i> our customer, we continue to share your information as described in this notice. How does St. Johns Bank & Trust Company collect my personal information?
