### WHAT DOES ST. VINCENT HOSPITAL CREDIT UNION DO WITH YOUR PERSONAL INFORMATION?

Financial companies choose how they share your personal infromation. Federal Law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share and protect your personal information. Please read this notice carefully to

### What?

The types of personal information we collect and share depend on the product or service you have with us.personal we collect and share depend on the product or service you have with us.

This information can include:

- Social Security Number and income
  Account Balances and payment history
- Credit History and Credit Scores

When you are no langer our member, we continue to share your information as described in this notice.

All Financial companies need to share customer's personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customer's personal information; the reasons St. Vincent Hospital Credit Union chooses to share; and whether you can limit this sharing

How does St. Vincent Hospital Credit Union protect my personal information?

To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.

### How does St. Vincent Hospital Credit Union collect my personal information? We collect your personal information, for example, when you;

- open an account or deposit moneypay your bills or apply for a loan
- use your credit or debit card

We also collect your personal information from others, such as credit bureaus, affiliates or other companies.

State laws and individual companies may give you additional rights to limit sharing. (See below for more on your rights under state law).

Affiliates- Companies related by common ownership or control. They can be financial or non-financial companies.

Non-Affiliates Companies not related by common ownership or control. They can be financial or non-financial Joint Marketing -A formal agreement between nonaffiliated financial companies that together market financial products or services to you. companies
