Why?	personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law requires us to tell you how we collect, share and protect your personal information. Please read this notice carefully to understand what we do.

What?	 share depend on the product or service you have with us. This information can include: Social Security number, date of birth and income Account balances and payment history Credit history and credit score When you are no longer our member, we continue to share your information as described in this notice.
How	All financial companies need to share member's personal information to run their everyday business. In the section below, we list the reasons financial companies can share their member's information; the reasons Texasgulf FCU chooses to share; and whether you can limit this sharing.

Other important information

What members can do to help- Texasgulf FCU is committed to protecting the privacy of its members. Members can help by following these simple guidelines; 1.Protect your account numbers, plastic card numbers, PINS (personal identification number), login or usernames and passwords. Never keep your PIN with your card, which can provide free access to your accounts if your card is lost or stolen. 2. Use caution when disclosing your account numbers, social calls you explaining the call is on behalf of Texasgulf FCU and asks for your account number or any other information, you should be aware. Official credit union staff will have access to your information and will not call you and ask for it. 3. Keep your personal information with us current. If your address or phone numbers change, please let us know immediately. It is important that we have current information to reach you. If we detect potentially fraudulent or unauthorized activity or use of an account, we will attempt to contact you immediately.
