Affiliates	<ul> <li>Companies related by common ownership or control.</li> <li>They can be financial and nonfinancial companies.</li> <li><i>Texas Telcom Credit Union has no affiliates.</i></li> </ul>	
Nonaffiliates	<ul> <li>Companies not related by common ownership or control. They can be financial or nonfinancial companies.</li> <li><i>Texas Telcom Credit Union does not share with nonaffiliates so they can market to you.</i></li> </ul>	
Joint marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you. <ul> <li>Our joint marketing partners include Insurance Companies and Credit Card Companies.</li> </ul>
