Affiliates	Companies related by common ownership or control. They can be financial and nonfinancial companies. • The CARLSBAD NATIONAL BANK has no affiliates
Non-affiliates	Companies not related by common ownership or control. They can be financial and nonfinancial companies. • The CARLSBAD NATIONAL BANK does not share with nonaffiliates so they can market to you
Joint Marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you. • The CARLSBAD NATIONAL BANK doesn't jointly market
