Definitions Affiliates	Companies related by common ownership or control.� They can be financial and nonfinancial companies. The Peoples Bank does not share information with affiliates
Nonaffiliates	Companies not related by common ownership or control.� They can be financial and nonfinancial companies. The Peoples Bank does not share with nonaffiliates so they can market to you
Joint marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you.
