Affiliates	Companies related by common ownership or control. They can be financial and nonfinancial companies. • Farmers National Bank of Lebanon has no affiliates.
Nonaffiliates	Companies not related by common ownership or control. They can be financial and nonfinancial companies. • Farmers National Bank of Lebanon does not share with nonaffiliates so they can market to you.
Joint marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you. Farmers National Bank of Lebanon does not jointly market with any other company.
