Financial Privacy Notice

Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.

What? The types of personal information we collect and share depend on the product or service you have with us. This information can include:

- Social Security number and payment history
- Income and transaction history
- Account balances and transaction or loss history

When you are no longer our customer, we continue to share your information as described in this notice.

How? All financial companies need to share customers' personal information to run their every day business. in the section below, we list the reasons financial companies can share their customers' personal information; the reasons First Farmers National Bank chooses to share; and whether you can limit this sharing.

Definitions

Affiliates Companies related by common ownership or control. They can be financial and nonfinancial companies.

NonAffiliates Companies not related by common ownership or control. They can be financial companies and non-financial companies.

• First Farmers National Bank does not share with nonaffiliates so that they can market to you

Joint Marketing A formal agreement between nonaffiliated financial companies that together market financial products to you.

• First Farmers National Bank does not jointly market.
