What we do			
How does First National Bank of Dwight protect my personal information?	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings. We do NOT disclose any information about you to anyone, except as permitted by law. Examples of this might include disclosures necessary to service your account or prevent unauthorized transactions.		
How does First National Bank of Dwight collect my personal information?	We collect your personal information, for example, when you Open an account Apply for a loan Make a wire transfer Make deposits or withdrawals from your account We also collect your personal information from others, such as credit bureaus, affiliates, or other companies.

Definitions	
Affiliates	Companies related by common ownership or control. They can be financial and nonfinancial companies. • First National Bank of Dwight does not share with our affiliates.
Nonaffiliates	Companies not related by common ownership or control. They can be financial and non-financial companies. • First National Bank of Dwight does not share with nonaffiliates so they can market to you.
Joint Marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you. • First National Bank of Dwight doesn't jointly market.

Other Important Information

For Alaska, Illinois, Maryland and North Dakota Customers. We will not share personal information with nonaffiliates either for them to market to you or for joint marketing- without your authorization.

For California Customers. We will not share personal information with nonaffiliates either for them to market to you or for joint marketing- without your authorization. We will also limit our sharing of personal information about you with our affiliates to comply with all California privacy laws that apply to us.

For Massachusetts, Mississippi and New Jersey Customers. We will not share personal information from deposit or share relationships with nonaffiliates either for them to market to you or for joint marketing- without your authorization.

For Vermont Members. We will not share personal information with nonaffiliates either for them to market to you or for joint marketing- without your authorization, and we will not share personal information with affiliates about your creditworthiness without your authorization.
