| How does First National Bank of Monterey protect my personal information? | To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.  We also maintain other physical, electronic and procedural safeguards to protect this information, and we limit access to information to those employees for whom access is appropriate. |  |  |  |
| How does First National Bank of Monterey collect my personal information? | We collect your personal information, for example, when you:  • Give us your contact information or open an account  • Provide account information or make a wire transfer  • Apply for a loan  We also collect your personal information from others, such as credit bureaus, affiliates, or other companies.  |  |  |  |
| Why can't I limit all sharing?  | Federal law gives you the right to limit only:  sharing for affiliates' everyday business purposes— information about your creditworthiness  affiliates from using your information to market to you sharing for non-affiliates to market to you  State laws and individual companies may give you additional rights to limit sharing.
