Affiliates	financial a	<ul><li>Companies related by common ownership or control. They can be financial and nonfinancial companies</li><li>Lyon County State Bank does not share with our affiliates.</li></ul>	
Nonaffiliates	<ul> <li>Companies not related by common ownership or control. They can be financial and nonfinancial companies.</li> <li>LyonCounty State Bank does not share with nonaffiliates so they can market to you.</li> </ul>		
Joint marketing	<ul> <li>A formal agreement between nonaffiliated financial companies that together market financial products or services to you.</li> <li>Lyon County State Bank doesn't jointly market.</li> </ul>
