Definitions		
Affiliates	Companies related by common ownership or control. They can be financial and nonfinancial companies. • Our affiliates include First Marblehead Corporation, First Marblehead Education Resources, First Marblehead Data Services and UFSB Private Student Loan SPV LLC.	
Nonaffiliates	Companies not related by common ownership or control. They can be financial and nonfinancial companies. Nonaffiliates we share with can include student loan lenders and servicers, retailers of education-related services, and nonprofit organizations.	
Joint marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you. UFSB doesn't jointly market.	

Other important information

California and Vermont Customers

For California Residents Only – If you live in California, we will not share your personal information with nonaffiliates, except for our everyday business and marketing purposes, or if you agree to such sharing on a separate form that we will send you. California residents do not have to contact us to implement these limits on our sharing.

For Vermont Residents Only – If you live in Vermont, we will not share your personal information with nonaffiliates, except for our everyday business and marketing purposes or if you agree to such sharing on a separate form that we will send you. Also, we will not share information about your creditworthiness with affiliates unless you agree to such sharing. We may share information about your transactions and experiences with affiliates for their everyday business purposes and to market to you, but you can stop them from using the information in marketing by checking the box marked "Do not allow your affiliates to use my personal information to market to me," on the Mail-in Form above. Vermont residents do not have to contact us to implement any other limits on our sharing.
