Privacy Policy Notice

FACTS: What does the University Federal Credit Union do with your personal information?

Why?	Financial companies choose how they share your personal information. Federal and state law gives consumers the right to limit some but not all sharing. Federal and state law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.
What?	The types of personal information we collect and share depend on the product or service you have with us. This information can include: • Social Security number and Date of Birth • Account Balances and Payment History When you are no longer our member, we continue to share your information as described in this notice.
How?	All financial companies need to share customers' or members' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' or members' personal information; the reasons University Federal Credit Union chooses to share; and whether you can limit this sharing.

What We Do

How does University Federal Credit Union protect my personal information?	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.
How does University Federal Credit Union collect my personal information?	We collect your personal information, for example, when you Open an account or deposit money Pay your bills or apply for a loan Use your debit card We also collect your personal information from others, such as credit bureaus, affiliates (if applicable), or other companies.
Why can't I limit all sharing?	Federal law gives you the right to limit only • Sharing for affiliates' everyday business purposes-information about your creditworthiness • Affiliates from using your information to market to you • Sharing for nonaffiliates to market you North Dakota state laws and individual companies may give you additional rights to limit sharing so that the credit union cannot participate in joint marketing arrangements.

Definitions

Everyday Business Purpose	The actions necessary by financial companies to run their business and manage customer/member accounts, such as: • Processing transactions, mailing, and audit services • Providing information to credit bureaus • Responding to court orders and legal investigations
Affiliates	Companies related by common ownership or control. They can be financial and nonfinancial companies. • University Federal Credit Union does not share with affiliates.
Non-affiliates	Companies not related by common ownership or control. They can be financial and nonfinancial companies.

	University Federal Credit Union does not share with nonaffiliates so they can market you.
Joint Marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you. • University Federal Credit Union does not participate in joint marketing arrangements.

Other Important Information

As a member of our credit union, you also have a responsibility to safeguard your financial information. Protect your account numbers, card numbers, PINs (personal identification numbers), and passwords. Use caution when you disclose your account numbers, social security numbers, etc. to other persons. Keep your contact information current. If we detect potentially fraudulent or unauthorized activity we will attempt to contact you immediately.
