Definitions	
Affiliates	Companies related by common ownership or control. They can be financial and non financial companies. <ul> <li>Valley Bank of Glasgow does not share with Affiliates.</li> </ul>
Nonaffiliates	<ul> <li>Companies not related by common ownership or control. They can be financial and non financial companies.</li> <li>Valley Bank of Glasgow does not share with Nonaffiliates so that they can market to you.</li> </ul>
Joint Marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you. <ul> <li>Valley Bank of Glasgow doesn't jointly market.</li> </ul>
