| Why?  | Financial companies choose how they share your<br>personal information. Federal law gives consumers the<br>right to limit some but not all sharing. Federal law also<br>requires us to tell you how we collect, share and protect<br>your personal information.<br>Please read this notice carefully to understand what we<br>do.  |
| What? | The types of personal information we collect and share<br>depend on the product or service you have with us. This<br>information can include:<br>-Social Security number and Income<br>-Credit history and Overdraft history<br>-Asset and Employment information<br>When you are <i>no longer</i> our customer, we continue to<br>share your information as described in this notice. |
| How?  | All financial companies need to share customers'<br>personal information to run their everyday business. In<br>the section below, we list the reasons financial<br>companies can share their customers' personal<br>information; the reasons Valley Green Bank chooses to<br>share; and whether you can limit this sharing.  |

| Why can't I limit all<br>sharing?                                    | Federal law gives you the right to limit only<br>-sharing for affiliates' everyday business purposes—<br>information about your creditworthiness<br>-affiliates from using your information to market to you<br>-sharing for nonaffiliates to market to you<br>State laws and individual companies may give you<br>additional rights to limit sharing. |

| Affiliates      | Companies related by common ownership or control.<br>They can be financial and nonfinancial companies.<br>-Valley Green Bank has no affiliates.   |

| Vonaffiliates   | Companies not related by common ownership or<br>control. They can be financial and non-financial<br>companiesValley Green Bank does not share with<br>nonaffiliates so they can market to you.  |
