- Social Security number
- Payment history
- Transaction history

- Loss history
- Credit history
- Overdraft history

When you are *no longer* our customer, we continue to share your information as described in this notice.

How?

All financial companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal information; the reasons Vantage Bank Texas chooses to share; and whether you can limit this sharing.

Affiliates	Companies related by common ownership or control. They can be financial and non-financial companies.  • Vantage Bank Texas has no affiliates.	
Nonaffiliates	Companies not related by common ownership or control. They can be financial and non-financial companies.  • Vantage Bank Texas does not share with nonaffiliates so they can market to you.	
Joint Marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you.  • Vantage Bank Texas does not jointly market.
