FACTS	WHAT DOES WAKOTA FEDERAL CREDIT UNION DO WITH YOUR PERSONAL INFORMATION?			
Why?	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.			
What?	The types of personal information we collect and share depend on the product or service you have with us. This information can include: • Social Security Number and Income • Account Balances and Payment History • Credit History and Credit Scores			
How?	All financial companies need to share member's personal information to rur their everyday business. In the section below, we list the reasons financial companies can share their members personal information; the reasons Wakota Federal Credit Union chooses to share; and whether you can limit this sharing.

Federal law gives you the right to limit only: • sharing for affiliates' everyday business purposes —information about your creditworthiness • affiliates from using your information to market to you • sharing for non-affiliates to market to you State laws and individual companies may give you additional rights to limit sharing.			
Definitions				
Non-affiliates	Companies not related by common ownership or control. They can be financial and non-financial companies. • CUNA Insurance			
Joint Marketing	A formal agreement between non-affiliated financial companies that together market financial products or services to you. • Wakota FCU does not have a formal joint marketing agreement
