WHAT WE DO

How does the Washington County Postal FCU protect your personal information?	We protect your personal information from unauthorized access and use security measures and comply with federal law. These measures include computer safeguards and secured files and buildings.
How does the Washington County Postal FCU collect personal information?	We collect your personal information, for example, when you: Open an account or deposit money Apply for a ban We may also collect your personal information from a credit bureau.

DEFINITIONS

Affiliates	Companies related by common ownership or control. They can be financial and nonfinancial companies.
Non affiliates	Companies not related by common ownership or control.
Joint marketing	A formal agreement between non affiliated financial companies that market financial products or services to your.
