## **FACTS** WHAT DOES WEBSTER FEDERAL CREDIT UNION DO WITH YOUR PERSONAL INFORMATION?

Why?	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.
What?	<ul> <li>The types of personal information we collect and share depend on the product or service you have with us. This information can include:</li> <li>Social Security number and checking account information</li> <li>credit card or other debt and credit history</li> <li>credit scores and payment history</li> <li>When you are <i>no longer</i> our member, we continue to share your information as described in this notice.</li> </ul>
How?	All financial companies need to share members' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their members' personal information; the reasons Webster Federal Credit Union chooses to share; and whether you

Definitions	
Affiliates	Companies related by common ownership or control. They can be financial and nonfinancial companies. - Webster Federal Credit Union has no affiliates.
Nonaffiliates	<ul> <li>Companies not related by common ownership or control. They can be financial and nonfinancial companies.</li> <li>Webster Federal Credit Union does not share with our nonaffiliates so they can market to you.</li> </ul>
Joint Marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you. - Webster Federal Credit Union doesn't jointly market.
