FACTS	WHAT DOES Westerly Community Credit Union DO WITH YOUR PERSONAL INFORMATION?	
Why?	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.	
What?	The types of personal information we collect and share depend on the product or service you have with us. This information can include: • Social Security Number and Income • Account Balances and Payment History • Credit History and Credit Scores When you are no longer our member, we continue to share your information as described in this notice.	
How?	All financial companies need to share members personal information to run their everyday business. In the section below, we list the reasons financial companies can share their members personal information; the reasons Westerly Community Credit Union (WCCU) chooses to share; and whether you can limit this sharing.

We have created this privacy statement in order to demonstrate our firm commitment to your privacy. The following discloses the information gathering and dissemination practices for our web site:

Visitors to the Westerly Community Credit Union web site will remain anonymous. We do not collect personal identifying information about visitors to our site.

We use your IP address to help diagnose problems with our server, and to administer our web site. Our servers collect standard nonidentifying information about visitors to the site, such as date and time visited, IP address, city, state, and country. This information is used to compile standard statistics on site usage.

We use cookies for our loan calculators, as well as to deliver content specific to your interests.

If you have provided identification (such as name and address) via e-mail or information request forms, the information will only be used to communicate with you to handle your request. It is not sold or transferred to other parties.
